

Health Guarantee

*****Please be certain that you are ready for the time commitment and financial Responsibility of a puppy prior to reserving a puppy with us.*****

A puppy is generally ready for its new home or to begin training at 8 weeks old, but it will be up to us as a breeder to determine when that puppy is ready for either.

We do our best to make sure that adoption is a perfect fit for you and your puppy. All our puppies come with a 2 year Genetic conditional health guarantee. We ask that you provide annual vet exams for your puppy and keep your puppy current on all shots and vaccines.

1. The puppy will be up-to-date on shots and de-worming at the time of pick up or delivery. Please continue vaccinations and de-worming according to your vet's recommended scheduling. You will receive a copy of our records of deworming and vaccinations.
2. The puppy will have been vet checked and deemed in good health at the time of the sale. You will receive a copy of our vets check of your puppy for your records as well.
3. **In order to not void** the 2 year Health guarantee, you *must have a Health check appointment scheduled for your puppy with a licensed veterinarian that will occur within 7 business days of receiving your puppy.* Any costs incurred will be the buyer's expense.
4. A scan or picture of said vet visit record/receipt must be sent to Lowell@Pleasantacrefarms.com **as proof** of your visit, to show it has occurred within the required time stated in #3.
5. If at the time of the required health check, a licensed veterinarian determines that the puppy is clinically ill or is deemed terminally ill due to a sickness or injury likely to have been contracted or received prior to date of delivery, you have the following options.
 - a. **Return the puppy for a complete refund**
 - b. **Return the puppy for a replacement puppy of equal value**
 - c. A written statement must be provided and signed and dated by your licensed veterinarian for both **A and B**
 - i. ****This does not include Minor illnesses and health issues such as cold, allergies, and internal or external parasites or umbilical hernias****
6. **If the puppy is deemed healthy by your licensed veterinarian, and we have RECIEVED proof of your visit**
 - a. *Your puppy is covered by a **2 year genetic health guarantee** that covers any disease or illness that is proven to be of genetic origin through proper veterinary examination and testing.*
 - b. **If your puppy is examined and you find a genetic disease/illness within this 2 year period, (health guarantee is from date of Birth) you may:**
 - i. **Retain your puppy and be refunded a max amount of half the purchase fee.**
 - ii. **Return the puppy in exchange for the exact same breed at no cost. (All travel is buyers responsibility)**

- c. Proper documentations must be provided prior to any compensation being paid or puppy exchanged.
 - i. *The Breeder reserves the right to have the puppy examined by a Licensed Vet (at the breeders expense) by a certified specialist before a refund or replacement puppy is given.*
- 7. *This guarantee does not*
 - a. cover normal veterinary costs incurred while providing general care for the puppy.
 - b. cover any costs incurred to injuries caused by owner negligence or accident injury
- 8. We do not guarantee against common illnesses such as Coccidia, Giardia, Worms, Kennel Cough, or hernias, and no guarantee is made as to the disposition or conformation of the dog. We do not guarantee the size of your adult dog.
- 9. **The buyer agrees to never place a puppy** in a shelter, pound, or research facility. We reserve all first refusal rights and require the the buyer to contact us should you no longer be able to care for or maintain a healthy environment for your puppy.

This Guarantee is provided to protect the health and general wellbeing of your puppy.
